PREAMBLE:

Industry has a curious relationship with the environment. Environmental management techniques are integral to conservation, agriculture, forestry, industry and countryside planning. This certificate course is designed for people already in environment-related employment, who wish to develop their careers by updating their knowledge and skills. It aims to satisfy an industrial and public sector demand for environmental management personnel.

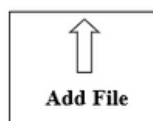
