

Applicants Selected for Admission to MBA (HRM) 2020-2022

The list of applicants selected for admission to the 2-Year Full Time MBA (HRM) Course 2020-2022 of IISWBM appears at the end of this message. Two alphabetically sorted lists have been brought out. Those of you who find your names in the 'First List' may take admission to the course right away, while those in the 'Waiting List' may do so only after 14th June 2020. All admissions after 14th June 2020 will be on first-come-first-serve basis and subject to availability of seats.

While you prepare to take admission, please note the following important points.

1. The first step towards taking admission is to pay the first year's course fees of Rs. 264,000 (Rupees two hundred sixty four thousand only). The fee structure of the course is as follows:

First year: Rs. 244,000 for admission, tuition and development fees
 Rs. 5,000 for *refundable* library caution money
 Rs. 5,000 for *refundable* security deposit
 Rs. 10,000 for student activities

Second year: Rs. 241,000 for tuition and development fees

2. You may pay the course fees by effecting a fund transfer through RTGS/NEFT in favour of IISWBM (Bank account details: Account Number 10252384198, State Bank of India, Surya Sen Street Branch, Kolkata, IFSC: SBIN0003496). Please take the screenshot of the payment reference or download the receipt and mail that promptly to mhrmoffice@iiswbm.edu.

3. Payment of fees only ensures a provisional admission for you. Final admission will take place only on compliance of the following:

a) Physical verification of all documents relating to your academic credentials and payment of fees – this will be done before the commencement of classes.

b) Approval of your qualifying degree/examination (that makes you eligible to apply for this course) by the University of Calcutta.

c) Passing with at least 50% marks in the aggregate for the qualifying examination – this is only for those who are in the process of completing their qualifying examination and the final results are yet to be published.

Failure on any of the above counts will result in cancellation of admission and the fees deposited will be refunded after deducting amounts as per AICTE norms.

4. If you have passed your last examination (graduate or post-graduate) from a university other than the University of Calcutta, you must obtain a Migration Certificate and submit the same to the University of Calcutta within one month from the date of commencement of the course.

5. The date of commencement of classes is a bit uncertain at this point of time and depends upon Government directives, University decisions and the ground situation. Please keep an eye on the Institute website for the latest announcement.
