4. Candidates who have passed their degree examination from a university other than University of Calcutta must get a Migration Certificate and submit the same to University of Calcutta within one month from the date of commencement of the course.
5. For those candidates for whom equivalence is required, admission will be provisional subject to equivalence approval from the University. Please contact the MBA office for details.
6. In view of the Covid-19 situation, admission will be provisional, subject to physical verification of documents and subsequent Equivalence approval from the University as deemed necessary. Physical verification will take place before the commencement of classes. Upon physical verification if it is found that any candidate does not meet the admission criterion, his / her admission will be cancelled and the money deposited will be refunded after deduction as per AICTE norms.
7. Final admission will be based on your qualification being approved by the University of Calcutta for this Course.
8. Students are required to furnish details of their local guardian including address, contact telephone / Mobile number and email ID.
9. In view of the Covid-19 situation, the date of commencement of classes will be announced later, depending on government circulars, University directives and subsequent decision taken by the Management of the Institute.
