: Rs. 20,000/- (seminars, colloquium, student activities fees)

Fee for the 2nd year : Rs. 2,94,000/- (including tuition and development fees)

- 3. Candidates who have been asked to deposit Certificate of Equivalence from University of Calcutta, must do so before depositing the fees, otherwise their candidature will be cancelled. For these candidates, admission will be provisional subject to equivalence approval from the University of Calcutta. Candidates are requested to apply immediately to get equivalence from University of Calcutta by 31<sup>st</sup> July, 2025.

- 4. The admission of candidates, who have appeared in the final examination and the results are yet to be published, will be provisional subject to the production of passing the Honours / Engineering degree or its equivalent Degree with minimum 50% marks in aggregate in graduation. The relevant documents will have to be submitted **by 25<sup>th</sup> September 2025**.
- 5. Final admission will be based on the eligibility qualification being approved by the University of Calcutta for admission to the Master of Business Administration Human Resource Management.
- 6. Candidates who have passed their degree examination from a university other than Calcutta University must get a Migration Certificate and submit the same to Calcutta University within one month from the date of commencement of the course.
- 7. **SC/ST/OBC** candidates who have not submitted their caste certificate along with the Admission Form must do so during the time of admission; otherwise their candidature will stand cancelled if they fail to be short-listed when considered in General Category.
- 8. Students are advised to arrange their own Laptop as advanced learning accessories.
- 9. Students are required to furnish details of their local guardian including address, contact telephone number, etc.
