**Essential Qualification:** Master degree in any discipline preferably with M.B.A. from UGC/ AICTE recognized University/ Institute.

**Essential Experiences:** At least 6 years' experience in Examination Cell/ Department of any University/ Institute and having experience in conducting/ coordinating examinations, moderation, arranging Board of Studies meeting, result compilation and allied work preferably for BBA and or MBA courses.

**Desirable Experiences:**

- i. Coordinating with faculty for ranking related exercises of the University/ Institute.
- ii. Assisting the administration in daily/ routine administration work.
- iii. Experience in affiliation related activity.
- iv. Coordinating research related activity of the University/ Institute.
- v. Experience in documentation and record keeping of admission & examination, research & publications etc. related issues.

**Age:** Candidate should not exceed age of 45 years as on last date of application.
