- The admission of candidates whose results of final or any other examinations are yet to be published, will be provisional subject to passing the eligible degree with minimum 50% marks in Honours. The relevant documents or equivalent or any pending marksheets will have to be submitted by **30th September, 2026** .
- Candidates who have passed their degree examination from a University other than University of Calcutta must get a Migration Certificate and submit the same to University of Calcutta within one month from the date of commencement of the course.
- For those candidates for whom equivalence is required, admission will be provisional subject to equivalence approval from the University of Calcutta . Candidates are requested to apply immediately to get equivalence from University of Calcutta and submit to MBA Office by **31st July, 2026** .
- Final admission will be subject to your qualification being approved by the University of Calcutta for this course.
- Students are required to furnish details of their local guardian including address, contact number and email ID.
