1. The list of selected candidates are placed in alphabetical order of their names.
2. The fees for the course are as follows :
 - (a) 1st Semester : Rs. 1,65,000/- (including Admission, Tuition and Development Fees)
: Rs. 5,000/- (refundable Library Caution Deposit)
: Rs. 5,000/- (refundable Security Deposit)
: Rs. 20,000/- (Student Activity & Value Added Courses)
 - (b) 2nd Semester : Rs. 1,45,000/- (including Tuition and Development Fees)
 - (c) 3rd Semester : Rs. 1,45,000/- (including Tuition and Development Fees)
 - (d) 4th Semester : Rs. 1,45,000/- (including Tuition and Development Fees)

Selected candidates are required to pay the first semester course fees, i.e., the sum of **Rs. 1,95,000/-** by any of the following options to reach the Institute by **30th June 2026** :

- * RTGS / NEFT transfer to IISWBM, State Bank of India, Surya Sen Street Branch, Kolkata

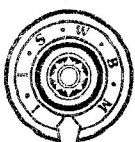
A copy of the receipt should reach MBA-HRM office of the Institute either by hand or by email (mhrmoffice@iiswbm.edu & fo@iiswbm.edu) on or before **30th June, 2026**.

3. **Candidates who have been asked to deposit Certificate of Equivalence from University of Calcutta, must do so before depositing the fees, otherwise their candidature will be cancelled.** For these candidates, admission will be provisional subject to equivalence approval from the University of Calcutta. Candidates are requested to apply immediately to get equivalence from University of Calcutta by **31st July, 2026**.
4. The admission of candidates whose results of final or any other examinations are yet to be published, will be provisional subject to passing the eligible degree with minimum 50% marks. The relevant documents or equivalent or any pending marksheets will have to be submitted by **30th September, 2026**.
5. **Final admission will be based on the eligibility qualification being approved by the University of Calcutta for admission to the Master of Business Administration – Human Resource Management.**
6. Candidates who have passed their degree examination from a University other than University of Calcutta must get a Migration Certificate and submit the same to University of Calcutta within one month from the date of commencement of the course. **SC/ST/OBC** candidates who have not submitted their caste certificate along with the Admission Form must do so during the time of admission; otherwise their candidature will stand cancelled if they fail to be short-listed when considered in General Category.
7. Students are advised to arrange their own Laptop as advanced learning accessories. Students are required to furnish details of their local guardian including address, contact number and email ID. For all admission related queries, please contact Sri Sudip Paul on 9836720566.

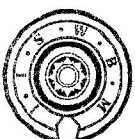
